Non-Immigrant Visa (Long Stay) “O-A”

This type of visa will be issued to applicants aged 50 years or above wishing to take retreat in the Kingdom for a period of at least one year.

Qualification of the applicant

1. Applicant must be aged 50 years and over (on the date of submitting the application).
2. Not being prohibited from entering the Kingdom under the Immigrant Act B.E. 2522 (A.D.1979).
3. Having no criminal record in Thailand, the country of the applicant 's nationality, or residence.
4. Having the nationality of or the residence in the country where application is submitted.
5. Not having prohibitive diseases (Leprosy, Tuberculosis, Drug Addiction, Elephantiasis and Third step of Syphilis) as indicated in the Ministerial Regulation No. 14 (B.E. 2535). Please see the example of medical certificate below
6. Not allowed to work in Thailand

Requirement for a Non-Immigrant Visa Long Stay category “ O-A” application.

1. Three application forms completely filled-out (no copy).
(For non-Swedish citizens, please contact the Embassy for information)
2. Three Additional application forms (completely filled-out (no copy) (See the form below).
3. Passport or travel document plus 3 copies (must be valid at least 18 months after the arrival date and must NOT be damaged.)
4. Three recent photos in colour or black & white, size 45mm X 35mm with white background (taken within the past 6 months)
5. Visa fees 1300 SEK in cash **(Fee paid in cash when submitting application)**
6. Evidence of adequate finance
 - a. Bank statement, 1 original plus 2 copies, showing a deposit account (cash only) of the amount equal to not less than 175,000 SEK (800,000 Baht), Document must be in English in original, stamp and sign by the issuer authorities and issued within the past 3 months.
 - b. A pension income certificate (an original in English) 1 original plus 2 copies, with montly income of not less than 14,500 SEK / month and after tax (65,000 baht)
 - c. A pension income certificate (per month x 12 months) can be combined with Bank statement equal to not less than 175,000 SEK (800,000 Baht), 1 original in English plus 2 copies
7. Criminal Record issued by Rikspolisstyrelsen (Utdrag ur belastningsregistret) 1 original in English plus 2 copies. Please check www.polisen.se (the verification shall be valid for not more than 3 months)
8. The original medical certificate, plus 2 copies, issued by medical doctor in the country where the application is submitted, showing no prohibitive diseases as indicated in the Ministerial Regulation No. 14 (B.E. 2535) (the verification shall be valid for not more than 3 months) (See the form below)
9. Extract of the population registration (Personbevis), 1 original in English plus 2 copies

Note: The Embassy does not provide copying or printing service. Please always bring your own copies. All the supporting documents must be issued within the past 3 months. The Embassy reserves the right to keep some documents as reference after processing your visa application.

**Process-time : High Season (September to February) at least 3 weeks
Low Season (March to August) at least 1 week**

How to use visa

With Long Stay O-A Visa you are allow to stay in Thailand for a period of maximum 1 year each time you enter Thailand *and you can enter Thailand many times during your visa validity. (The issue date of your visa is the date that you submit your application).*

*****Note: You have to report to the competent authority every 90 days with
the Immigration officer in your residential area.*****

Recommendations for foreigners with Non-Immigrant Visa (Long Stay) “O-A” while staying in the Kingdom

1. Upon arrival, holder of this type of visa will be permitted to stay in Thailand for 1 year from the date of first entry.
2. At the end of the 90-day stay, the foreigner must report to the immigration officer in his/her residence area and report again every 90 days during his/her stays in Thailand. The foreigner may report to the police station if there is no immigration office in his/her residence area.
3. Foreigner may report to the competent authority by post and should provide the following:
 - A report form (*Tor Mor 47*).
 - A copy of passport pages showing the foreigner’s photo, personal details, and the latest arrival visa stamp.
 - A copy of the previous receipt of acknowledgement.
 - A self-addressed envelope with postage affixed.

Such documents must be sent to the Office of the Immigration Bureau, Soi Suan Plu, South Sathorn Road, Sathorn District, Bangkok 10120, and must be submitted 7 days before the end of every 90-day period. A receipt of acknowledgement will be given and should be used for future correspondence.

4. Foreigner who wishes to extend his/her stay shall submit a request for extension of stay at the Office of the Immigration Bureau with documented evidence of money transfer or a deposit account in Thailand or an income certificate showing an amount of not less than 800,000 Baht **or** an income certificate plus a deposit account showing a total amount of not less than 800,000 Baht. A one-year extension of stay shall be granted at the discretion of the immigration officer to the foreigner as long as he/she meets the above requirements.

Remarks

- ❖ The Embassy will not process a visa application if the application is not complete.
- ❖ The Embassy reserves the right to request more documents or ask for an interview.
- ❖ The Embassy will not return the visa fee paid if your application has been declined.
- ❖ The Embassy will not return the documents that you have submitted.
- ❖ After collecting the passport with issued visa, the applicant should check the visa carefully to make sure it accords with your purposes and supposed visit to Thailand. If there are any doubts, you must raise it immediately with the staff. Otherwise the applicants will take all the consequences by themselves.
