

NON – IMMIGRANT VISA “O”

Requirement for a Non Immigrant Visa “O” application

1. An application form completely filled-out. **(for non-Swedish citizenship, please contact the Embassy)**
2. Passport or travel document (must be valid at least 6 months for single entry after the arrival date to Thailand or 18 months for multiple entry and must not be damaged)
3. Two recent photos in colour or

black & white, size 45mm X 35mm with white background.(taken within the past 6 months)

4. Fee 520 sek per person for single entry
Fee 1,300 sek per person for multiple entries **(Fee paid in cash when submitting application)**

A. If you are married to a Thai citizen or have a relation with a Thai citizen as parents or children to a Thai citizen, the following documents must be submitted.

1. Copy of document indicating that you have a relation with a Thai citizen
 - Copy of Marriage certificate (Original copy might be requested to show to officer) and Personbevis indicating that you are married with a Thai citizen (issued not more than 3 months)
 - Copy of Birth Certificate or Personbevis, indicating that you are the parents or children of a Thai citizen
2. Copy of Thai ID card or Thai passport of your Thai spouse or child

B. If you are retired and aged 50 and above the following documents must be submitted.

1. Evidence of adequate finance
 - A Pension income certificate from Social Insurance (försäkringskassan) or Private insurances company with amount of not less than 14,500 SEK per month after tax (65,000 Baht)

OR

 - Bank statements showing deposit account (cash only) not less than 44,500 SEK (200,000 Baht). Document must be original, stamped and signed by authorizer and issued within the past 3 months.
In case of showing the Bank statement, you must prepare pensioner card or evidence in the form of writing showing that you are pensioner.
2. Extract of the population registration (Personbevis) or copy of your ID card

Note: The Embassy does not provide copying or printing service. Please always bring your own copies. All the supporting documents must be issued within the past 3 months. The Embassy reserves the right to keep some documents as reference after processing your visa application.

How to use visa ***Single Entry** (One entry) The visa holders must use the visa to enter Thailand within 90 days from the date of issue. The issued date of your visa is the date when you submit your application. Please do not apply for a visa earlier than 3 months before your expected date of arrival in Thailand.

With single entry you can stay in Thailand for a maximum of 90 days from the date of entry into Thailand.

* **Multiple Entry** (multiple entries) The visa holders must use the visa to enter Thailand within 1 year from the date of issue. The issued date of your visa is the date when you submit your application. *With multiple entries, you can enter Thailand many times within 1 year and each time you can stay in Thailand for a maximum of 90 days from the date of arrival in Thailand. You are not allowed to stay in Thailand over 1 year without leaving the country otherwise you must pay for over stay fees.*

*To extend the period of your stay, please contact Immigration Bureau in Thailand www.immigration.go.th

Attention : Application in person or by a representative at the Royal Thai Embassy.

The Embassy does not accept nor retrun visa application by post.

Process-time : **High Season** (September to February) at least 3 working days.
Low Season (March to August) at least 1 working day (not the same day)

Remarks

- ❖ The Embassy will not process a visa application if the application is not complete.
- ❖ The Embassy reserves the right to request more documents or ask for an interview.
- ❖ The Embassy will not return the visa fee paid if your application has been declined.
- ❖ The Embassy will not return the documents that you have submitted.
- ❖ After collecting the passport with issued visa. The applicant should check the visa carefully to make sure it accords with your purposes and supposed visit to Thailand. If there are any doubts, you must raise it immediately with the staff. Otherwise the applicants will take all the consequences by themselves.
